 information on the transfer document must be saying: **POZWOLENIE RADIOWE + Name of the Yacht**
- If you applying on behalf of the ship's owner **Power Of Attorney (POA) document** clearly stating the particulars of both parties (the owner and the appointed representative) and the subject of appointment (i.e. to represent the owner before UKE in the process of applying for Ship Radio License) *please note that additional payment will be required – see information below.*
- If you applying on behalf of the ship's owner and attaching *Power of attorney document* then you are required to pay additional fee of 17 PLN so a proof of payment should be for 99 PLN (82 + 17 PLN).
